## GENERAL CONDITIONS FOR ADMISSION

1. All the above selected candidates are awarded a Government of India fellowship @Rs.5,000/- (Rupees five thousand only) per month, subject to complete submission of required documents. There are no other allowances.
2. All the selected candidates shall be allotted a Hostel accommodation within the Institute's campus on sharing basis at subsidized rate, **subject to availability**.
3. The entire process of uploading/ furnishing documents, verification of document, payment of fee and admissions is ONLINE. No applicant or any of their Guardians/relatives will be physically allowed at the Institute Campus for admission process or submitting any document.
4. Physical verification of all documents will be done later. The candidature of all applicants in the whole admission process is "PURELY PROVISIONAL" pending scrutiny of eligibility as mentioned in the Admission Bulletin 2025-26 for the programme. In case, it is found at any stage of admission that the applicant does not fulfill the eligibility criteria and any information/ document provided by the applicant is found to be false or is not in conformity with the eligibility criteria mentioned in the Admission Bulletin 2025-26 including Age, Caste Category, Sub-Category, Educational Qualification, etc. the candidature of such an applicant will summarily be rejected at any stage of admission process and even after admissions.

6. All the selected candidates must fill up the online admission form & remit their fees online **on or before July 14, 2025**. It is extremely important that applicants pay the fee within the timeframe allocated, failing which it will be concluded that the candidate is not interested in the programme applied and the admission will be automatically cancelled and the vacant seat/s shall be offered to the next eligible candidate/s as per rule. No communication or correspondence of any sort from the defaulters shall not be entertained.
7. The procedure for uploading the requisite documents by the candidate must be completed within the stipulated time interval as notified in the provisional admission list, failing which you will lose your opportunity for admissions in the IIPS Mumbai. It is the responsibility of the candidate to check if the documents have been uploaded properly, otherwise application will be rejected.
8. Candidates belonging to SC/ST/PWD/ward of Kashmiri Migrants and Kashmiri Pandit/ Kashmiri Hindu families (Non-Migrants) Living in Kashmiri Valley category must upload valid certificate issued by the competent authority, at the time of online admission.

9. In case of candidates belonging to OBC/ EWS category must produce recent/ valid “Non Creamy Layer”/ EWS certificate issued by the competent authority as per Government of India norms. The caste of candidates belonging to OBC must be valid in accordance with the castes of **Central List of OBCs published by the Government of India**, at the time of admission. Else, the offer will stand cancelled. Institute will not consider the state lists of OBCs. In case of OBC-NCL/ EWS category, the certificate must be issued on or after April 01, 2025.

12. The hard copy of Provisional Admission Letter can be collected from the Examination Cell/ Academic Section at the time of physically joining the programme.
13. In case of any discrepancy, Institute reserves the right to cancel selection list or name of candidates at any time.
14. If violation of the above points is detected at any stage of the admission process, candidature can be cancelled.
