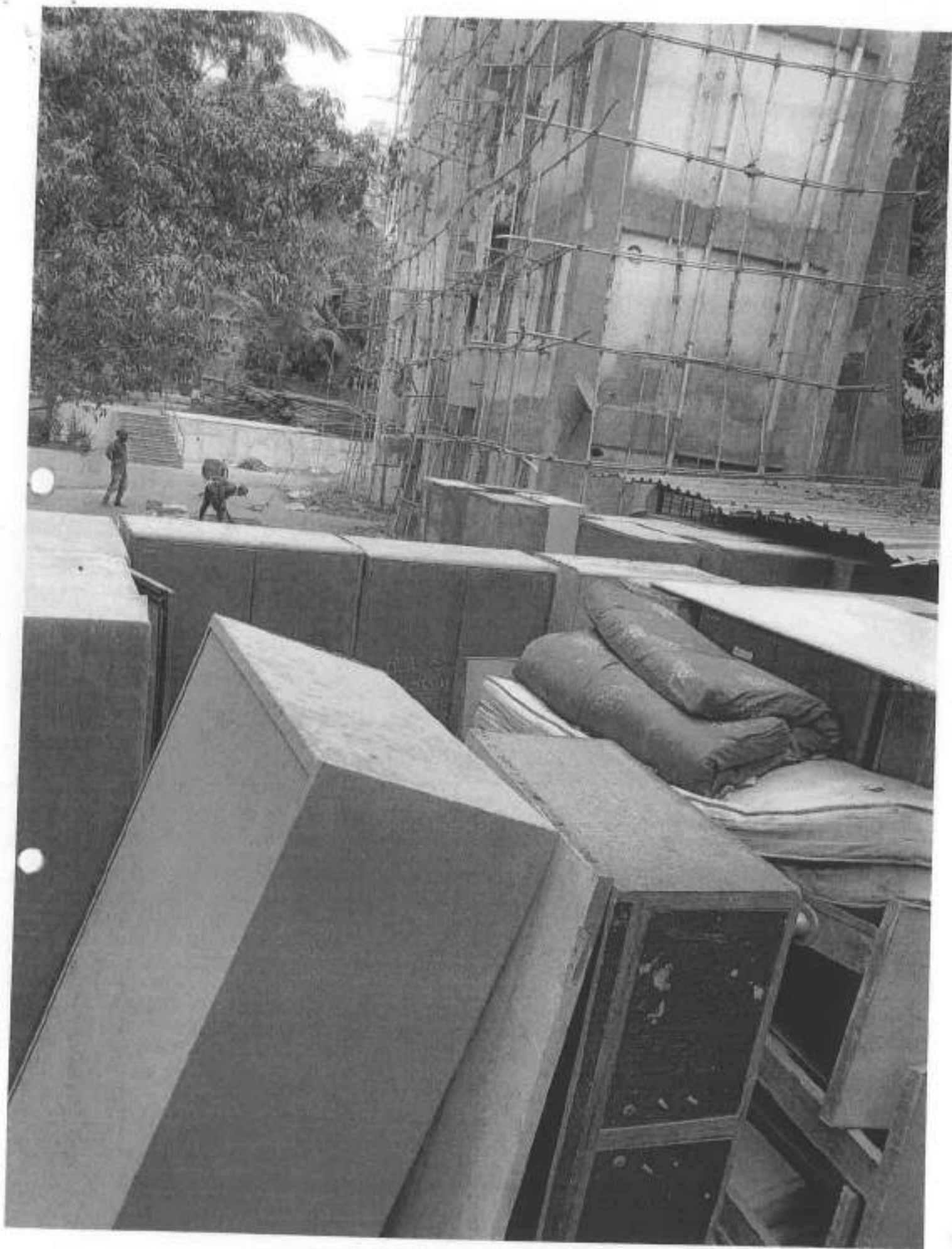

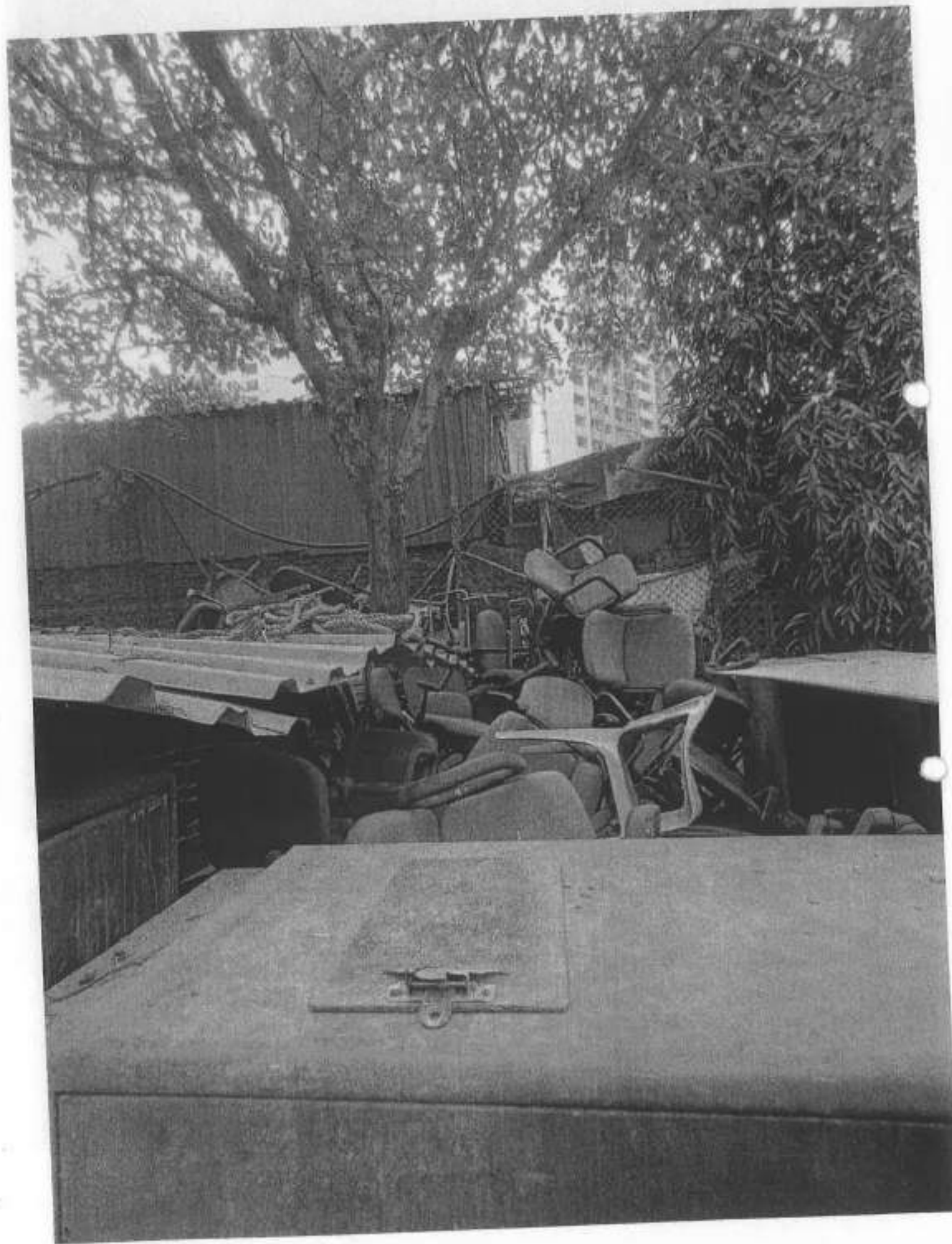

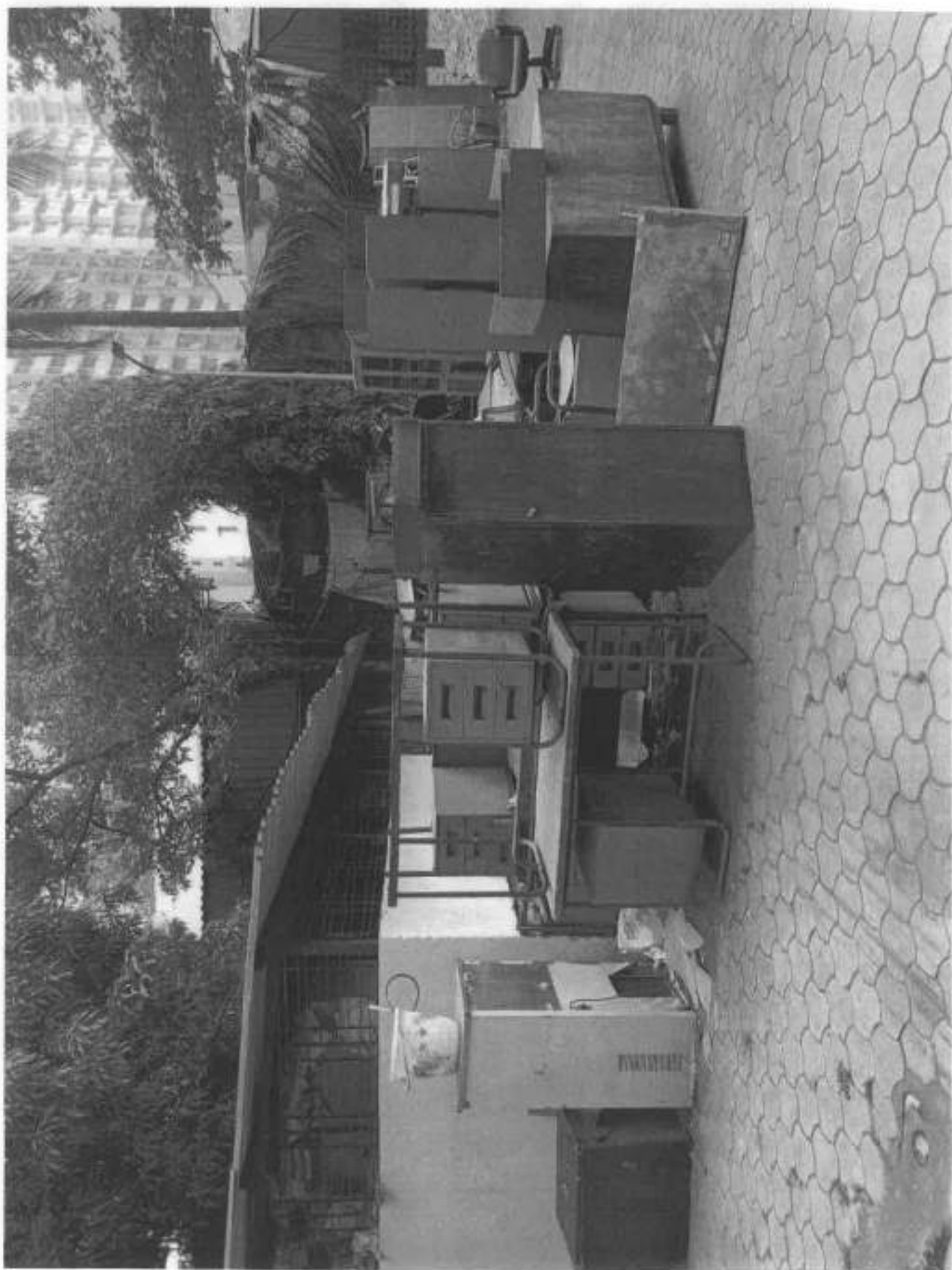

- 4.0 अब एतद्वारा सहमत होकर इसके पक्षकारों द्वारा निम्नानुसार घोषित किया जाता है:- NOW it is hereby agreed and declared by the parties hereto as follows:
- 4.1 इस करार में उपरोक्त अनुच्छेद 2 में उल्लेखानुसार सभी चल/अचल वस्तुओं तथा सभी अधिशेष, कन्डेम्नड/स्कैप/अप्रचलित सामग्रियों तथा द्वितीयक उत्पन्न पदार्थों (लोह तथा अलोह) के साथ-साथ उपकरणों, संयंत्रों, मशीनरियों एवं अन्य वस्तुओं आदि के निपटान हेतु एमएसटीसी ऑक्शन वेब साईट www.mstcecommerce.com के माध्यम से होगा। This Agreement covers disposal of all movable/immovable items and all surplus, condemned/scrap/obsolete materials and secondary arising (ferrous and non-ferrous) as well as equipments, Plant, Machineries, properties and misc. articles etc.; through MSTC's Auction web site www.mstcecommerce.com as mentioned in clause-2.0 above;

4.2 उपर्युक्त के अलावा इस करार में परस्पर सहमति से भी निपटान श्रेणी हेतु अन्य वस्तुएं शामिल की जाएगी। In addition to the above, add-ons to the category of disposals may be effected through this agreement on mutual consent.

- 7.9 एमएसटीसी प्रिंसिपल के पास जमा करने हेतु ग्राहकों से बिक्री मूल्य/बिड मूल्य संग्रह करेगा। सफल क्रेताओं के लिए एमएसटीसी के किसी भी कार्यालय में जमा करने का विकल्प रहेगा। प्रिंसिपल के पास क्रेताओं द्वारा जमा किए गए उनके भुगतानों से संबंधित आंकड़ों में एमएसटीसी की वेबसाइट पर एक्सेस का विकल्प रहेगा।/MSTC shall collect sale price/bid money from the buyers for onward submission to the Principal. - 8.6 एमएसटीसी को सामग्री की सूची को अधेष्टित करते हुए प्रिंसिपल प्रत्येक लॉट के लिए जीएसटी की दर का संकेत देंगे।/The Principal will indicate rate of GST for each lot while forwarding the list of material to MSTC.
- 8.7 एमएसटीसी प्रिंसिपल को सामग्री की बिक्री की मानक शर्तें एवं निबंधन उपलब्ध कराएगा। प्रिंसिपल एमएसटीसी पर एमएसटीसी की बिक्री की मानक शर्तों में कोई फेरबदल करने पर जोर नहीं देगा। /MSTC shall provide its standard terms and conditions of sale of materials to the Principal. The Principal will not insist on MSTC for any deviation from standard terms of sale of MSTC.
- 9.0 सेवा प्रभार / SERVICE CHARGE
- 9.1 एमएसटीसी इंटरनेट पर ई-ऑक्शन के माध्यम से जारी डिलीवरी आर्डर के मूल्य के आधार पर पहुँचे निपटान सामग्री के मूल्य पर सेवा प्रभार 3%(जीएसटी अतिरिक्त) का हकदार होगा। सेवा प्रभार पर लागू जीएसटी प्रिंसिपल द्वारा देय होगा।/MSTC shall be entitled to a service charge of 3% (excluding GST) on the value of materials disposed, arrived on the basis of the value of the Delivery Order (D.O.) issued through e-auction over the Internet. GST as applicable on Service Charges shall be payable by Principal.
- 9.2 सेवा प्रभार की गणना सामग्री पर जीएसटी को छोड़कर की गई राशि पर की जाएगी।/Service Charge will be calculated on the amount realised excluding GST on material.

of material value plus GST minus TDS on service charge) & another in favor of Principal (balance of the material value plus GST on material & TDS of MSTC).

10.0 करार के कार्यान्वयन हेतु स्थायी समिति/ STANDING COMMITTEE FOR IMPLEMENTATION OF THE AGREEMENT

इस करार से संबंधित मामलों पर कार्रवाई करने के लिए प्रिंसिपल तथा एमएसटीसी अपने एक-एक अधिकारी को नामित करेंगे। इस करार के प्रावधानों के कार्यान्वयन हेतु कार्य व्यवस्था का निर्णय परस्पर विचार-विमर्श के आधार पर किया जाएगा।/The Principal and MSTC will nominate one official each for dealing with all matters relating to this Agreement. The working arrangements for implementing the provisions of this Agreement shall be mutually discussed and decided upon.

11.0 बिक्री करार का निष्पादन /EXECUTION OF SALE CONTRACT :

इस करार के निष्पादन के समय प्रिंसिपल के मौजूदा बिक्री करार (करारों) का प्रचालन जारी रहेगा और वह इस करार के दायरे में नहीं आएगा(आएंगे)। इसी प्रकार यह करार समाप्त होने पर एमएसटीसी द्वारा बुक किए आर्डरों का प्रचालन जारी रहेगा, माना उन आर्डरों के निष्पादित होने तक यह करार जारी रहता है।/Sale Contract(s) of the Principal existing at the time of execution of this Agreement will continue to operate and will not come under the purview of this Agreement. Similarly, at the expiry of this Agreement, the orders booked by MSTC will continue to operate as if this Agreement continues till the execution of those orders.

12.0 मुकदमों का संचालन HANDLING OF SUITS :

एमएसटीसी प्रिंसिपल हेतु केवल विक्रय अभिकर्ता/सेवा प्रदाता के रूप में कार्य करेगा, प्रिंसिपल सामग्री का स्वामी / विक्रेता है, बोलीदाताओं / खरीदारों द्वारा आह्वान किए गए मध्यस्थता सहित सभी मुकदमे, यदि कोई हो, तो विशेष रूप से प्रिंसिपल द्वारा निपटा जाएगा ; चाहे एमएसटीसी ऐसी कार्यवाही में एक पार्टी के रूप में शामिल हो या न हो। मध्यस्थता सहित सभी सूट / कानूनी कार्यवाही को संभालने की जिम्मेदारी प्रिंसिपल की होगी, जो कि किसी भी खरीदार / बोलीदाता द्वारा शुरू की गई हो या उसके खिलाफ की गई हो और खुद का बचाव हेतु की गई हो। ऐसी सभी कार्यवाही स्वयं की लागत और व्यय पर की जाएगी । प्रिंसिपल के सक्षम अधिकारियों को भी एकमात्र मध्यस्थ नियुक्त करने की आवश्यकता हो सकती है, यदि इस तरह की नियुक्ति के लिए बोलीदाता / ग्राहक द्वारा संबंधित निविदा / नीलामी / ई-नीलामी के नियमों के अनुसार किया जाता है। यदि मैसर्स एमएसटीसी की गलती पर अदालत का मामला उठता है, तो जिम्मेदारी मैसर्स एमएसटीसी,

मुंबई की होगी।/Since MSTC will only act as Selling Agent/Service Provider to the Principal who is the Owner/Seller of the materials, all litigations including arbitration, if any invoked by the Bidders/Buyers shall be exclusively dealt with by the Principal irrespective of whether MSTC is joined in such proceedings as a party or not. It shall be responsibility of the Principal to handle all suits/legal proceedings including arbitration that may initiated by or against any buyer/bidder and to defend itself in all such proceedings at its own costs and expenses. The competent officials of the Principal shall be also required to appoint the Sole Arbitrator in case request for such appointment is made by Bidder/Customer in terms of the relevant Tender/Auction/e-Auction Clauses. If court case arises on the fault of M/s MSTC, then responsibility will be of M/s MSTC, Mumbai.

13.0 न्यायालय का अधिकार क्षेत्र /JURISDICTION OF THE COURT:

14.0 संशोधन/A M E N D M E N T :

इस करार में कोई संशोधन तभी संशोधन होगा जब वह लिखित में और इस करार के पक्षकारों के अधिकृत प्रतिनिधियों द्वारा विधिवत हस्ताक्षरित हो।

Any amendment to this Agreement would be enforceable only if made in writing and duly signed by authorised representatives of the parties hereto.

15.0 अप्रत्याशित घटना खंड /FORCE MAJEURE CLAUSE :
