In addition Academic Council also approved the similar procedure for deciding the best dissertation award in the M.Sc. in Survey Research and Data Analytics alike other PG programme. The above will be awarded from the academic year 2025-2026.

Agenda no 7:

To discuss & approve the revised syllabus of all PG programmes including M.A. (Distance Education).

The AC was briefed by the Prof. Aparajita Chattopadhyay, Chairperson regarding the background of the revision of syllabus for master degree courses in line with NEP-2020.

Course coordinators have made brief presentation on the revised two year PG course syllabus namely MA/M.Sc, MBD, MSD & MA (distance education). Also presented the semester wise credit distribution along with research components in

fourth semester. IKS, value added course and non-credit internship are included in revised course syllabus as per NEP guideline. The revised syllabus will be implemented from the academic year 2025-26.

It has been decided that in case of MA (distance learning), at least 50% of the first year paper required to be passed before the upgradation into second year. Chairperson has suggested to maintain the uniformity of IKS syllabus for regular and distance learning.

The members of AC approved the revised syllabus w.e.f 2025-26. (Annexure C)

Rationale

The M.Sc. programme in Survey Research and Data Analytics is launched to address the increasing need for data-driven decision-making. This programme offers students a unique blend of rigorous academic instruction and practical exposure. It equips them with proficiency in survey design, data management, and multivariable statistical techniques, alongside hands-on training in software such as STATA, R, and Python.

Drawing students from diverse academic disciplines—including statistics, mathematics and computer science—the programme fosters a dynamic learning environment. Leveraging IIPS's long-standing institutional strengths in survey execution and research, students are well-prepared to take up professional roles in leading governmental and non-governmental organizations at national and international levels.

Internship Placement

Students will be placed in reputed governmental or non-governmental organisations, where they will gain hands-on experience in the domains of survey research and data analytics.

Internship Assignments

During the internship, students are expected to undertake tasks assigned by their host organisations. These assignments may involve, but are not limited to:

- Designing and analyzing large-scale survey datasets or data sets given by the organizations
- Interpreting demographic and public health trends using different software learned during first year

of the programme

Students are expected to demonstrate analytical rigor and technical proficiency in the task assigned to them by the organizations.

Internship Seminars

Upon completion of the internship, students are required to present their work at IIPS in a formal Internship Seminar. This presentation provides an opportunity for peer learning and constructive academic feedback.

Based on suggestions and comments received during the seminar, students must revise and finalize their reports. The final Internship Report must be submitted to the Academic Section of IIPS within one week of the seminar.

Internship Report

Each student must submit a comprehensive report detailing the work carried out during the internship. The report should highlight the application of survey research and data analytics techniques learned during the programme and reflect the key insights gained through fieldwork and data analysis.

Students are strongly encouraged to begin compiling their reports well before the conclusion of their internship to ensure timely and quality submission. A certificate of completion from the host organisation may be attached with the report.

Important Dates

1. **Internship Seminar Presentation at IIPS:** To be scheduled after commencement of the third semester, preferably within the first month.

2. Submission of Final Internship Report: Within one week after the Internship Seminar at IIPS.
