

## Memorandum of Cooperation /協力覚書



Between :

The International Institute for Population Sciences, (hereinafter called "IIPS"), A Deemed-to-be-University under the administrative control of the Ministry of Health & Family Welfare, Government of India.

### And

The National Institute of Population and Social Security Research (hereinafter called "IPSS").

Each is individually called a "Participant", collectively called the "Participants".

Participants decided as follows :

## Background

IIPS is a public research institute and a University, specialized in population studies, that works in partnership with the academic and research communities at national and international levels. 当事者:

## 背景

IIPS は、人口研究を専門的に行う公的研究機関・大学であり、国内及び国際的 な学術及び研究関係者と協力して活動している。

IIPS's missions is to strive to be a centre of excellence on all population and relevant issues through high quality education, teaching, and research. This is achieved by

Creating competent professionals,

Generating and disseminating scientific knowledge and evidence,

Collaborating and exchanging knowledge, and

Advocacy and awareness.

IPSS is a public research institute created by merging the Institute of Population Problems founded in 1939 and the Social Development Research Institute founded in 1965. Along with investigating the trends of population and households, the Institute carries out research concerning social security policies and systems in Japan and abroad.

These same tasks, in a shared domain, brought IIPS and IPSS to introduce a collaboration, noting the Agreement between the Government of Japan and the Government of India on co-operation in the field of science and technology.

### 1. PURPOSE

This Memorandum of Cooperation (hereinafter called "the Memorandum") is to confirm the common intention of the Participants to cooperate in order to promote joint research/ teaching.

2. SCOPE OF THE PARTNERSHIP

社人研は、1939年に設立された厚生省人口問題研究所と1965年に設立され た特殊法人社会保障研究所との統合によって創設された公的研究機関であ る。この機関は、人口や世帯の動向を調査するとともに、日本及び海外の社 会保障政策及び制度に関する研究を行っている。

IIPS と社人研は、科学技術の分野における協力に関する日本国政府とインド 政府との間の協定に留意しつつ、共有する分野でのこれらの共通する課題に おいて、協力を実現することとなった。

### 1. 目的

本協力覚書(以下「本覚書」という。)は、共同研究又は指導を推進す るために協力するという両当事者の共通の意図を確認するものである。

2. 協力関係の範囲

The partnership covers two fields:

research activities;

 dissemination and promotion of research. This can be implemented through various forms, in particular:

- a. exchange of visits by researchers to participate in workshops, seminars and conferences;
- b. sharing data, when possible, such as sample surveys, statistics and databases;
- c. development of joint research projects by the Participants;
- d. jointly-held workshops, seminars and conferences, and all other types of scientific events by the Participants;
- e. publishing the outcome;
- f. collaboration between libraries and/or documentation centres;
- g. Acceptance of visiting researchers

The implementation plan will be drafted in line with the present Memorandum.

## 5.1. Commencement of Cooperation and Duration

Cooperation under this Memorandum will commence on the signature date and continues for a period of 2 years. Cooperation under this Memorandum will be automatically renewed every two years after the period of 2 years unless it is ended.

## 5.2. Discontinuation

Cooperation under this Memorandum may be ended at any time by either Participant.

The discontinuation is implemented by registered mail with return receipt, with at least 6 months prior notice which certifies the receipt by the other Participant of the request for discontinuation.

This Memorandum is not legally binding but a document of intention, and does not create any legal right and obligation between the Participants under domestic and international law.

This Memorandum is written in English and Japanese, all texts having equal values. In cases of conflicting interpretation concerning this Memorandum, English version will prevail.

L'IIPS a été créé en juillet 1956 sous le parrainage conjoint du Sir Dorabji Tata Trust, du gouvernement indien et des Nations unies. Il sert de centre régional de formation et de recherche en études démographiques pour la région ESCAP. L'IIPS a été le premier centre de ce type à voir le jour et il dessert une population beaucoup plus importante que n'importe quel autre centre régional. L'Institut est placé sous le contrôle administratif du ministère de la santé et du bienêtre familial du gouvernement indien joue un rôle essentiel dans la planification et le développement du pays.

Cette convergence d'intérêts sur les questions de population a amené l'Ined et l'IIPS à initier une collaboration, afin de promouvoir et réaliser des travaux de formation et de recherche scientifique en démographie et sciences sociales.

Il a donc été convenu et arrêté ce qui suit :

ARTICLE 1 - OBJET

Le présent accord-cadre a pour objet de définir le cadre d'un partenariat entre les Parties.

## ARTICLE 2 - DUREE

Le présent accord-cadre entre en vigueur à la date de sa signature par la dernière des Parties pour une durée de 5 ans.

Il est notifié par le dernier signataire à l'autre Partie par courrier recommandé avec accusé de réception. IIPS was established in July 1956 under the joint sponsorship of the Sir Dorabji Tata Trust, the Government of India and the United Nations. It serves as a regional center for training and research in population studies for the ESCAP region, IIPS was the first such center to be established and serves a much larger population than any other regional center. The Institute is under the administrative control of the Ministry of Health and Family Welfare of the Government of India and plays a vital role in the planning and development of the country.

This convergence of interest on population issues led Ined and IIPS to initiate a collaboration, to promote and carry out training and scientific research in demography and social sciences.

It is mutually agreed as follows:

### ARTICLE 1st - PURPOSE

The purpose of this Memorandum of Understanding is to define the framework for a partnership between the Parties.

### ARTICLE 2 - DURATION

The present memorandum of understanding shall come into force on the date of its signature by the last of the Parties for a period of 5 years.

It shall be notified by the last signatory to the other party, by registered letter with return receipt.

It may be renewed by amendment submitted by one Party to the other, at the latest three months before expiry.

## <u>Memorandum of Understanding</u> <u>Between</u> <u>University of California San Diego, U.S.A. and</u> International Institute for Population Sciences, India

This non-binding Memorandum of Understanding (MOU) is entered into by and between The Regents of the University of California, on behalf of the San Diego campus (UC San Diego), and the International Institute for Population Sciences (IIPS). UC San Diego and IIPS agree that continued cooperation in research and evaluation to expand the understanding of gender inequalities in India, as well as the health and social effects thereof, would be mutually beneficial. The areas of cooperation may include, subject to prior written mutual consent:

- a. Faculty and scholar mobility and training;
- b. Student mobility and training;
- c. Joint research projects, including data analysis and academic manuscript writing;
- d. Publications, materials and information exchange;
- e. Shared curricula for courses in the fields of social sciences and health; and
- f. Special short-term trainings, programs, seminars and visits.

Date

The primary contacts for this MOU are Dr. K.S. James for IIPS and Prof. Lotus McDougal for UC San Diego. The parties may enter into specific written agreements hereunder to clarify and define the nature, extent and terms of proposed collaborations, including regarding intellectual property ownership and funding issues. Any such agreements shall require the approval of appropriate officers from each institution. This MOU is intended to exist for five (5) years unless terminated by one of the parties. Either institution may withdraw from this MOU at any time and for any reason, provided written notification of the withdrawal is given to the other institution. This MOU is made in English, which is the authentic text. This MOU will begin on the later date of signing by both parties. This MOU may not be enforced in any legal proceeding.

PREAMBLE

General provisions

 The procedure for a dual doctoral degree programme between Universität Rostock and the IIPS is designed to establish and develop academic and scientific cooperation by promoting the mobility of PhD candidates.

The general provisions of the agreement, particularly those relating to the protection of thesis topics as well as the publication, use and protection of the results of research common to the two host Departments of the PhD candidate are required to be in conformity both with the specific procedures in each of the two countries as well as the relevant internal regulations of each institution.

PART I: Administrative matters

Article 1 The doctoral candidate to whom this agreement pertains is

Poulami Barman Born: 26/02/1998 Nationality: Indian

The University of Rostock and the IIPS agree to register Poulami Barman as a doctoral candidate, under joint supervision of the University of Rostock and the IIPS.

Article 2 The doctoral candidate is jointly supervised by:

1. Prof. Dr. Gabriele Doblhammer University of Rostock Department of Sociology and Demography Faculty of Economic and Social Sciences

1. Prof. Nandita Saikia International Institute for Population Sciences Department of Public Health & Mortality Studies





## Article 3

1. The agreement for the dual doctoral degree is effective from 1st January 2023. The expected period of research is set to 3 years from the beginning of the agreement at the University of Rostock. These 3 years might be followed by an extension of 1 more year subject to the approvals of the supervisor at the University of Rostock and IIPS. The salary will be covered by Prof. Doblhammer's funds from the German Center for Neurodegenerative Disease. The doctoral thesis is expected to be submitted to the Faculty of Economic and Social Sciences of the University of Rostock and IIPS by 31<sup>st</sup> August 2026. Under exceptional circumstances and given the availability of external funds the period can be extended to a maximum of six years, no extension thereafter is possible.

- The doctoral candidate will be stationed at the IIPS over the period January 1<sup>st</sup> August 31<sup>st</sup>, 2023. The doctoral candidate will be stationed at the University of Rostock over the period Sept 1<sup>st</sup> 2023 – August 31<sup>st</sup> 2026.
- The doctoral candidate shall pay the stipulated fee to the IIPS for the entire duration of the PhD programme.
- The doctoral candidate shall pay the stipulated fee to the University of Rostock for at least one year of her dissertation phase.
- The IIPS shall pay fellowship to the candidate only for the period of the candidate's stay at the IIPS.
- The University of Rostock shall pay the salary of the candidate only for the period of the candidate's stay at the University of Rostock

### Article 4

The University of Rostock and the IIPS will instruct the doctoral candidate to register at both institutions.

### Article 5

The doctoral candidate must prove sufficient health insurance coverage for the full period of her stay in Rostock and in India, as well as a personal liability insurance.

### Article 6

Research work should be conducted in both institutions according to a timetable jointly drawn up by the two thesis supervisors (at least 6 months in each institution). This timetable is also set out in Appendix 1.

Any amendment to this timetable should be requested from both signatory institutions by the thesis supervisors at least one month in advance.

### Article 7

Both institutions recognize the validity of the research project undertaken by the doctoral candidate. All rules of the partner institutions pertaining to scientific publications are in force.



## PART II: Research supervision and thesis preparation

### Article 8

- Prof. Dr. Gabriele Doblhammer, appointed as a Professor at the University of Rostock, and Prof. Nandita Saikia, appointed as a Professor at the IIPS, are designated as joint supervisors.
- 2. The supervisors will consult regularly on the research progress of the doctoral candidate. The supervision is equally divided between both institutions. Each institute will invest 50% of the allotted time for supervision. The daily supervision and scientific mentoring resides with the supervisor located where the research work is being undertaken at that particular moment.

### Article 9

- The theme of the dissertation is: Risk Factors and Patterns of Cognition and Dementia in the Aging Populations of India and Germany.
- The dissertation will be written in English. A summary of the dissertation will be written in German and English.
- Both partner institutions will instruct the doctoral candidate to follow the rules of both institutions concerning the registering, the description and the reproduction of the thesis.
- 4. In line with the regulations of the University of Rostock on the PhD thesis, the dissertation is a cumulative thesis consisting of at least three papers, an introduction and a discussion. One paper must be a single author publication worked out by the PhD candidate. Of these three papers, two should be published papers in peer-reviewed journals and one must be under review.

### Article 10

The research project will be carried out at both institutions following a research plan that is jointly approved by the doctoral supervisors.

### Article 11

 The intellectual property rights of the thesis, the publication, the use and protection of the research results shall be safeguarded in accordance with the specific regulations of both institutions.

### PART III: Evaluation and conferral of degree

### Article 12

 In line with the PhD regulations of the two institutions the University of Rostock and the IIPS will identify two full professors (neither connected to University of Rostock nor IIPS) employed





by a university who have not co-authored with the doctoral candidate for independently evaluating the PhD thesis.

- The identification of the two full professors will be done by mutual consent between the partner institutions, in accordance with the regulations in force at the partner institutions.
- 3. After the positive assessment of the two supervisors and the two external Professors the thesis can be submitted to the Faculty of Economic and Social Sciences at the University of Rostock and the IIPS. According to the regulations of the University of Rostock the two supervisors have to submit written evaluations of the PhD including grades. According to the regulations of the IIPS, the two external Professors have to submit written evaluations of the PhD thesis. After having received positive evaluations of the supervisors and the two external Professors the Faculty of Economic and Social Sciences at the University of Rostock and the IIPS will set the date for the public defence of her dissertation, which will take place at the University of Rostock. The defence will be assessed and headed by the Examining Committee.
- 4. The Examining Committee shall consist of at least 7 persons;
  - the head of the Examining Committee, Director & Senior Professor IIPS, who is the chair
  - the two supervisors,
  - one professor from the University of Rostock,
  - one professor from the IIPS
  - one external Professor (neither connected to University of Rostock nor IIPS)
  - one post-doc from Rostock's Faculty of Economic and Social Sciences

### Article 13

- Approval for defence of a thesis is granted jointly by the two institutions, according to the legal and regulatory provisions in force in both places.
- According to the regulations of the two universities the thesis will be presented and defended during a public ceremony at the University of Rostock, but is duly recognized by the IIPS.
- 3. The PhD ceremony, including the defense of the PhD thesis, will be conducted in English.
- After the Examining Committee has given a favourable recommendation the University of Rostock and the IIPS will confer upon the candidate the doctoral degree of the University of Rostock and of the IIPS.
- 5. The University of Rostock will award the degree of Doctor in Economics and Social Sciences (Dr. rer. pol.). In conformity with the doctoral regulations of the University of Rostock the Examining Committee grades the doctorate examination procedure with: summa cum laude, magna cum laude, cum laude or rite. The final grade of the University of Rostock consists of the two grades of the evaluations by the supervisors and a grade for the presentation and the public defence. The IIPS will award the degree of Doctor of Philosophy in Biostatistics and Demography (in English).
- Each University will issue its own degree certificate which will mention the joint nature of the supervision by the partner institutions, leading to the award of a dual doctorate.

### Article 14

The present agreement holds as long as necessary for the completion of the doctoral degree. The agreement may be reviewed on an annual basis by each institution and may be terminated if good





reason is found to do so. In addition, the agreement may be termination the initiative of the doctoral candidate or following collegial advice from the doctoral supervisors. As long as the agreement is in force the institutions commit themselves to supporting the doctoral candidate in continuing the project.

### General provisions

### Article 15

The parties will comply with all applicable local and national laws and regulations with respect to activity under this Agreement, including law related to anti-bribery, economic sanctions, export control, anti-boycott, privacy and data protection, higher education, and accreditation standards or procedures.

The institutions will comply with EU General Data Protection Regulation applicable since 25 May 2018 and other applicable legislation and regulations concerning the processing of Personal Information. Parties will determine in good faith how they will apply these laws and the data processing principles cooperating within IIPS and University of Rostock.

### Article 16

Activities carried out under this Agreement will be done without the disclosure of either institution's confidential or proprietary information to the other institution or to third parties. Should it become necessary for the institutions to disclose to each other confidential or proprietary information, the providing institution will notify the receiving institution in advance and in writing, and the institutions will agree on reasonable terms for the protection of such information. All confidential information will be clearly marked as such, or promptly disclosed as such, in writing.

## This Faculty Exchange Agreement dated the 30<sup>th</sup> day of December, 2023

## BETWEEN:

## **THE UNIVERSITY OF MANITOBA**, Canada ("UM") On behalf of its Institute of Global Public Health

## AND

# INTERNATIONAL INSTITUTE POPULATION SCIENCES, India ("IIPS")

WHEREAS:

- A. IIPS and UM (the "institutions") have expressed their desire to establish a cooperative relationship through a Faculty Exchange Agreement (the "FEA").
- NOW, THEREFORE, the institutions agree as follows:

## 1- Definitions

- (i) *"Exchange*" means the reciprocal exchange of Faculty Members and Graduate Students between the institutions;
- (ii) *"Faculty Member"* means an academic staff member of one of the institutions, including persons holding the rank of Professor, Associate Professor, Assistant Professor, Lecturer or Librarian; or Researcher;
- (iii) *"Graduate Student"* means a student enrolled at the Home Institution in a graduate program and conducting thesis research towards graduate program requirements;
- (iv) *"Home Institution"* means the institution at which a Visiting Scholar is normally employed as a Faculty Member or Post-Doctoral fellow, or is enrolled as a Graduate Student;

- (v) *"Host Faculty"* means the faculty, school, department, or institute at the Host Institution where the Visiting Scholar is to perform their period of scholarly work;
- (vi) *"Host Institution"* means the institution which has agreed to receive the Visiting Scholar for a period of scholarly work;
- (vii) *"Placement Site"* means a facility operated by a third party at which the Visiting Scholar carries out some or all of their scholarly work;
- (viii) *"Post-Doctoral Fellow"* means any individual holding the position of Post-Doctoral Fellow at the Home Institution;
- (ix) *"Supervising Faculty"* means a Faculty Member at the Host Institution, assigned to assist and supervise a Visiting Scholar;
- (x) *"Visiting Scholar"* means a Faculty Member, a Post-Doctoral Fellow or a Graduate Student selected to participate in the Exchange.

## 2- Purpose and Scope

- 2.01 The purpose of this Agreement is to facilitate the exchange of Visiting Scholars on an ongoing basis.
- 2.02 Each Visiting Scholar may engage in a period of scholarly work at the Host Institution for a period of time acceptable to the Host Institution and Host Faculty.
- 2.03 Scholarly work performed by Visiting Scholars may include:
  - (a) Sabbatical leaves;
  - (b) Post-doctoral or graduate student studies;
  - (c) Participation in joint research projects;
  - (d) Giving lectures, seminars, or colloquia; and
  - (e) Any other areas of mutual scholarly interest.
- 2.04 It is not a requirement that each institution host the same number of Visiting Scholars in any one (1) year period. However, efforts toward reciprocity should be maintained over a five (5) year cycle.

## **3-** Initiation of Exchange

3.01 A Faculty Member, Post-Doctoral Fellow or Graduate Student nominated by the Home Institution to be a Visiting Scholar must be in good standing and eligible to participate in the Exchange under the applicable policies and collective agreements of the Home Institution.

- 3.02 Any visit by a Visiting Scholar requires prior approval of the UM Dean, the IIPS Director and the head of any school, department or centre involved. The timing and any arrangements of a visit should be clearly defined before approval as well as the terms of reference of the collaboration or exchange.
- 3.03 The Home Institution may periodically submit a request to the Host Faculty, which shall include:
  - (a) the name of a Faculty Member, Graduate Student or Post-Doctoral Fellow nominated by the Home Institution to become Visiting Scholar;
  - (b) the time at which each nominated Faculty Member, Graduate Student or Post-Doctoral Fellow wishes to commence and complete participation in the Exchange;
  - (c) information regarding the qualifications of each nominated Faculty Member, Graduate Student or Post-Doctoral Fellow, including a curriculum vitae;
  - (d) information regarding the nature of the scholarly work each nominated Faculty Member, Graduate Student or Post-Doctoral Fellow intends to perform on the Exchange; Graduate Students should include the title of current thesis project;
  - (e) information regarding the facilities, equipment, and access the Faculty Member, Graduate Student or Post-Doctoral Fellow requires for the purposes of their scholarly work; and
  - (f) any other information requested by the Host Institution.
- 3.04 Upon receiving the request, the Host Faculty shall consider the feasibility of hosting the Visiting Scholar. A nominated Visiting Scholar may be refused if an appropriate Host Faculty does not have available space or capacity to host the Visiting Scholar.
- 3.05 In reply to the request of the Home Institution, if the nomination is approved, the Host Faculty shall provide:
  - (a) a letter of acceptance to the Visiting Scholar;
  - (b) the Host Faculty to which the Visiting Scholar is assigned; and
  - (c) any special requirements imposed on the Visiting Scholar.
- 3.06 It is understood that Host Faculties shall be entitled to determine the extent to which they will be able to host the Visiting Scholar. A Host Faculty or Host Institution shall be entitled to determine, in its absolute discretion:
  - (a) the number of Visiting Scholars the Host Faculty is willing to accommodate;
  - (b) whether it will accept a particular nominated Visiting Scholar;
  - (c) the nature of the scholarly work that the Visiting Scholar may perform;
  - (d) the Supervising Faculty assigned to the Visiting Scholar;
  - (e) the facilities, equipment and access that will be made available to Visiting Scholar; and
  - (f) any special requirements for Visiting Scholar at the Host Faculty.

3.07 It is further understood that the Host Institution may refuse to accept a nominated Visiting Scholar if the request is not received in sufficient time to permit the required processing and consideration in advance of the requested date for commencement of participation in the Exchange.

## 4- Financial Terms

- 4.01 Salary (where applicable) shall be paid to the Visiting Scholar by the Home Institution. The Host Institution shall not be liable for the payment of any wages or benefits to the Visiting Scholar, unless otherwise agreed to in writing. The Visiting Scholar shall not be or become an employee of the Host Institution under the terms of this Agreement.
- 4.02 Visiting Scholar will pay any compulsory and optional fees typically charged to Faculty Members, Graduate Students or Post-Doctoral Fellows (as applicable) of the Host Institution, including:
  - (a) Athletic facility memberships;
  - (b) Club memberships;
  - (c) Fines or penalties;
  - (d) Parking expenses; and
  - (e) Any other cost or fee generally paid by Faculty Members of the Host Institution.
- 4.03 Where a Visiting Scholar has completed the Exchange, but has failed to pay all amounts owing to the Host Institution, the Home Institution shall take reasonable steps to assist with the collection of such debt.

## 5- Visiting Scholar Rights & Responsibilities

- 5.01 Visiting Scholar shall not be considered as a Faculty Member, Post-Doctoral Fellow or Graduate Student of the Host Institution. In particular:
  - (a) Visiting Scholar shall not be entitled to the procedural protections regarding discipline or dismissal of Faculty Members, Post-Doctoral Fellows, and Graduate Students (as applicable); and
  - (b) The Host Institution may revoke its invitation for a Visiting Scholar at any time, in its absolute discretion.
- 5.02 Except as noted herein, a Visiting Scholar is subject to the policies, regulations, bylaws, procedures, and rules of the Host Institution.
- 5.03 Visiting Scholar is responsible for obtaining the necessary immigration documents or visas to permit their participation in the Exchange.
- 5.04 It is the responsibility of a Visiting Scholar to arrange appropriate medical, disability and liability insurance.

- 5.05 Visiting Scholar is responsible for all personal expenses related to the Exchange, including: -
  - (a) Travel expenses;
  - (b) Immigration expenses;
  - (c) Accommodation;
  - (d) Food;
  - (e) Transportation costs;
  - (f) Medical and travel insurance; and
  - (g) Other living expenses.

## 6- Assistance for Visiting Scholar

- 6.01 Each institution shall appoint a Supervising Faculty member as a contact person to assist or mentor each Visiting Scholar.
- 6.02 The Host Institution shall: -
  - (a) provide orientation by the Host Faculty for the Visiting Scholar upon arrival;
  - (b) provide information related to accommodation for the Visiting Scholar for the duration of the visit;
  - (c) provide ongoing advice and support through the contact staff member.
- 6.03 The Host Faculty shall use its best efforts to arrange for a Visiting Scholar to be provided with reasonable facilities for the conduct of their scholarly work, including: -
  - (a) office and/or laboratory space;
  - (b) access to computer facilities;
  - (c) access to office supplies;
  - (d) access to libraries; and
  - (e) any other facilities, equipment, or access which is reasonably available and necessary for the purposes of the Exchange.

## 7- Placement Sites

- 7.01 By mutual agreement, a Visiting Scholar may engage in some or all of their scholarly work at a Placement Site outside the Host Institution as long as this work fits within the research proposed by this Agreement. A separate agreement may be furnished between the Host Institution and the Placement Site, and the Host Institution shall be responsible for such process.
- 7.02 The Host Institution shall assist the Visiting Scholar to identify and manage the collaboration with the Placement Site.

- 7.03 The Host Institution shall use its best efforts to ensure that the Visiting Scholar working at a Placement Site shall:
  - (a) follow all policies, regulations, by-laws, procedures, and rules of the Placement Site;
  - (b) respect all applicable laws related to privacy and confidentiality, and upon request, undergo privacy training and sign pledges of confidentiality;
  - (c) refrain from creating any undue risks to clients or patients of the Placement Site; and
  - (d) follow any other requirements of the Host Faculty or Placement Site.
- 7.04 The Host Institution or the Placement Site may remove a Visiting Scholar from the Placement Site if, in their opinion, the Visiting Scholar has failed to meet their obligations under this Agreement.

## 8- Ethics Approval

8.01 Where the nature of a research project undertaken by a Visiting Scholar requires human or animal ethics approval, the Host Institution will ensure that an appropriate approval is obtained from either the Home or Host Institution, to be determined on a project to project basis.

## 9- Intellectual Property

- 9.01 The Visiting Scholar shall acknowledge the Host Institution in any publications related to work done during the Exchange.
- 9.02 Unless agreed otherwise or as set out in a separate specific project agreement, the parties acknowledge and accept that each party is bound to apply its own internal policies including those relating to intellectual property ownership and use.

## **10-Duration and Termination**

- 10.01 This Agreement will be effective upon signature by the respective signing authorities or their delegates for a period of five (5) years, at which time it may be reviewed for possible renewal for further five (5) year period.
- 10.02 This Agreement may be terminated by either institution on one (1) month notice in writing.
- 10.03 Termination of this Agreement shall prevent the selection of additional Visiting Scholars, but the institutions shall honour all commitments to Visiting Scholars already accepted or participating in the Exchange at the date of termination.

- 11.01 Each institution shall be liable for the actions and omissions of its own employees, officers, and agents with respect to this Agreement, and shall save the other institution harmless in relation to all loss or damage caused to Visiting Scholars or other third parties.
- 11.02 Neither institution shall be liable for the actions and omissions of third party Placement Sites, their employees, officers, and agents with respect to this Agreement.
- 11.03 The rights and obligations under this Agreement may not be assigned.
- 11.04 Neither institution shall be liable for failure to fulfill obligations under this Agreement, where such failure results from strikes or work stoppages, legal restrictions, weather, fire, natural disasters, or any other reason beyond the control of the institution.

## 12-Counterparts

12.01 This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery by *facsimile* or by electronic transmission in portable document format (PDF) of an executed counterpart of this Agreement is as effective as delivery of an originally executed counterpart of this Agreement.

### Preamble

This agreement will lay grounds for future cooperations in research and teaching activities between both parties.

### Partner profile

This convergence of interest on migration issues led UWK and IIPS to initiate a collaboration, to promote and carry out teaching, research, training and academic exchange in social as well as applied sciences.

### (a) University for Continuing Education Krems (UWK)

UWK is the leading public University for Continuing Education in Europe. Its area of activities includes both teaching and research work. The Department for Migration and Globalisation (DEMIG) as an academic unit of UWK will be in charge of this cooperation and collaboration DEMIG conducts research on migration with particular focus on migration processes and drivers; migration policy and governance and integration and social cohesion. ### (b) International Institute for Population Sciences, Deemed to be University (IIPS)

IIPS was established in July 1956 under the joint sponsorship of the Sir Dorabji Tata Trust, the Government of India and the United Nations It serves as a regional centre for training and research in populations studies for the ESCAP region. IIPS was the first such centre to be established and serves a much larger population than any other regional centre. The Institute is under the administrative control of the Ministry of Health and Family Welfare of the Government of India and plays a vital role in the planning and development of the country.

### It is mutually agreed as follows.

## ARTICLE 1 - Purpose

The purpose of the memorandum of understanding is to define the framework for a partnership between the parties.

## ARTICLE 2 - Subject matter and objective of the cooperation or scope of the partnership

The partnership applies to the following four broad activity fields:

- Research
- Dissemination and promotion of research
- Academic exchange

It can be implemented through various forms, in particular.

- Reciprocal hosting of researchers, faculty, and students,
- Developing joint proposals for research grants and conducting collaborative research,
- Collaborative organisation of academic events (workshops, seminars/conferences etc.),
- Production of collaborative publications

To this end, the partnership may lead to the collaborative teaching, research and mobilisation of collective resources as well as financial support dedicated to specific courses and projects.

## **ARTICLE 3 - Data Protection**

Until the conclusion of an appropriate cooperation agreement each partner institution shall independently be responsible for processing third-party personal data under the planned cooperation

The partner institutions acknowledge that as part of the present Memorandum of Understanding personal data of the relevant other partner institution (e.g. data of contact persons) will be processed, which is necessary for the performance of this Memorandum of Understanding in accordance with Art. 6 (1) (b) of the General Data Protection Regulation (GDPR)

## ARTICLE 4 - Know-how; Confidentiality; Logo protection

Disclosure and provision of know-how in connection with the cooperation and the resulting data, texts and documents shall include no transfer of the rights attached thereto.

None of the partner institutions shall be entitled to exploit the know-how of the other partner institution commercially or to apply for registration of industrial property rights regarding the other party's know-how

Both partner institutions undertake to keep strictly secret vis-a-vis third parties internal business information which becomes known to them in the course of their cooperation prior to, during or after the cooperation.

The name and the logo of UWK are protected under trademark law and the style and spelling of the same in letters, printed matter, etc. is a material part of the CI policy of UWK. Any use of the name or the logo of UWK, in particular for advertising measures, shall be subject to prior written approval from the UWK Marketing Unit.

Any use of the name or the logo of IIPS, in particular for commercial purposes, shall be subject to prior written approval from the competent authority of IIPS.

## ARTICLE 5 - Duration and Termination

This Memorandum of Understanding constitutes a letter of intent of both partner institutions.

This Memorandum of Understanding on cooperation shall enter into force on the date of its signature, for an initial period of five (5) years. It will automatically prolong for another five (5) years if not canceled six (6) months before the end of the duration in writing

Notwithstanding the time period, this MoU may be terminated at any time by either Party Such termination shall be effected by sending a registered letter and an email with acknowledgement of receipt to the other Party, subject to six months' notice from the receipt of such letter Termination of this MoU shall not automatically result in the termination of any agreement taken in application of this memorandum and the already started joint projects or activities The obligations listed in Art 4 that are required to be met beyond the termination of the MoU shall remain in effect

## ARTICLE 6 - Financial Provisions

This is a non-financial agreement where neither parties owe any financial liability.

## ARTICLE 7 - Juridical terms

Each agreement taken in application of this memorandum is written with reference to it. It specifies the purpose, defines the teaching/training/research/exchange programme, appoints one manager/Coordinator/PIs by party. It also specifies duration of activities (which should not end after the present memorandum), and, where appropriate, human resources involved, financial resources, material resources, the administrative modalities, the rules of confidentiality, the regime of the intellectual property, the dissemination of results, the applicable law and the competent courts.

### 1.0 PURPOSE

Both UT and IIPS may be referred to individually as the "party" or collectively as the "parties".

### 2.0 SCOPE OF ACTIVITIES

UT and IIPS aim to undertake cooperation in areas that may include, but are not restricted to, the following:

- a) Student visits for research and study
- b) Faculty, staff and research scholars visits
- c) Joint research activities
- d) English as a Second Language programs
- e) Continuing education programs
- f) Organization and participation in seminars, symposia, short-term academic programs and academic meetings
- g) Exchange of research and educational materials, publications and academic information
- h) Technical assistance
- Creation and marketing of electronic instruction media, including credit and non-credit courses
- j) Dual degree and joint degree programs
- k) [List other, if applicable]

### 3.0 ACTIVITY AGREEMENTS

Before any activities may be implemented, the parties shall discuss the relevant issues to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the activity. Activity agreements will include such terms as the following.

 Elaboration of the responsibilities of each institution for the agreed upon activity



- b) Specific schedules for the activity
- c) Budgets and sources of finances for the activity
- Detailed management of intellectual property rights and publications
- Any other items deemed necessary for the efficient management of the activity

### 4.0 COORDINATORS

Coordinators shall be named by each institution to serve as liaisons for implementing this MOU. All activities conducted under the auspices of this MOU must have the endorsement of the coordinators. At UT, the coordinator will be Madhuri Sharma, Associate Professor of Geography and Sustainability and at IIPS, the coordinator will be Kailash Das, Department Head of Migration and Urban Studies. Coordinators shall notify their counterparts in writing should a new person be named to the position.

### 5.0 RENEWAL, TERMINATION AND AMENDMENT

- 5.1 This MOU shall remain in force for a period of five years from the date of the last signature. This MOU may be extended by the written consent of the parties.
- 5.2 This MOU may be terminated by either party giving written notice to the other party at least 30 days in advance of the stated termination date. Termination of this MOU shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.
- 5.3 This MOU may be amended only by the written consent of the parties.

### This Memorandum of Understanding is made at <u>Mumbai</u> on 03<sup>rd</sup>-Day of April, 2023

#### Between

**Directorate of Census Operations, Maharashtra**, Ministry of Home Affairs, Government of India, with Office at <u>Mumbai (hereinafter referred as "First Party</u>", which expression shall, unless repugnant to the meaning of the context thereof, means and includes its representative(s), executors and permitted assigns) of the First Party.

#### AND

**International Institute for Population Sciences (IIPS), Mumbai** (hereinafter referred as "**Second Party**", which expression shall, unless repugnant to the meaning of the context thereof, means and includes its representatives, executors and permitted assigns) of the Second Party.

#### I. BACKGROUND

01. The Office of Registrar General & Census Commissioner, India (ORG&CCI) is an attached office of the Ministry of Home Affairs and has currently 35 offices all over the country. Besides the Head Office at New Delhi and Language Division at Kolkata, 33 offices are located in States/UTs and are known as Directorate of Census Operations (DCOs). The Office of Registrar General and Census Commissioner, India (ORG&CCI) has its own administrative setup. The office is responsible for:

- Conduct of decennial Population Census under the Census Act 1948, tabulate and disseminate the Census data;
- Coordinating and unifying at the National level, the work under the Registration of Births and Deaths Act, 1969;
- Estimating at the National and State level, fertility and mortality rates through the Sample Registration System (SRS);
- Preparation of National Register of Indian Citizens as since 2003, Registrar General, India has been designated as National Registration Authority and Registrar General of Citizen Registration under the Citizenship (Amendment) Act, 2003.
- Preparation & updation of National Population Register (NPR)
- Rendering Technical & Logistics Support for conduct of different statistical exercises for different departments like AHS, SECC etc. in the past

02. Conduct of the Census is a role assigned to Government of India, under the Constitution. The Indian Census has a rich tradition and enjoys the reputation of being one of the best in the world. The first Census in India was conducted in the year 1872. This was conducted at different points of time in different parts of the country. In 1881, the Census was conducted for the entire country simultaneously. Since then, Census has been conducted every ten years, without a break in spite of several adversities like wars, epidemics, natural calamities, political unrest, etc. This mammoth administrative exercise of collection of micro level data for the entire country, requiring huge commitment of manpower and material resources, is conducted by the Government of India every ten years with the active support of States/UTs. Census, 2011 is the fifteenth in this unbroken series since 1872 and the seventh after independence.

03. The Post-Census operations call for tabulation of the data collected during Census, in proper format, at the earliest, with high level of accuracy, to make it available for use by all concerned. Accordingly, after every Census, ORGI and DCOs publish a wealth of data with regard to statistics on population.

04. At the time of each decennial Census huge array of information is collected from each person in the country on various subjects like social, demographic, economic and other related aspects. Information is also collected about the household and about housing condition, amenities and assets available.

05. This huge information collected is then used to generate specific preformatted tables for use by a wide range of data users. At the Census 2011, more than **300 tables** were generated using the database of information on more than 1.20 billion people. Besides, on request from data users customized tables are also generated for their specific use from the database.

06. As **information is power and as collection of information** itself is very costly, many countries allow researchers the access to such a huge dataset as in Census for individual **research**. The ORGI has also extended this facility to the **researchers and established** 18 Workstations in different Universities/Institutes for research on micro-data from Indian Census.

07. The Census Act 1948 stipulates that the information given by any respondent at the decennial Census is be treated as confidential. Such information is also prohibited from being presented or used as exhibits in any court of law. The census data published by the Office of the Registrar General & Census Commissioner, India is in the form of aggregate tables at various administrative levels like, the country, state, district, sub-district, town, village or ward in town as the case may be, where it is not possible to identify the individual(s) to whom these relate to. While allowing research on micro-data it is therefore utmost important to anonymize the data to protect confidentiality by masking the location and a few sensitive fields. After anonymizing the record

level data, the dataset is made available for in-depth research at the workstations on varying characteristics of the population of the country. The researchers are permitted to generate cross tabulations using the micro-data sets but are not permitted to copy or take out the data from the workstation.

#### **II. OBJECTIVE**

08. The objective for setting up the Workstation is to permit qualified researchers optimum use of anonymized micro-data from census for in-depth research by allowing access for generating cross tabulations not published by the Census. The facility is open to all including those who are not enrolled or part of the university.

09. Such research would not only allow greater utilization of data by way of generating cross-tabulations from confidential micro-data not otherwise possible by using aggregate level data available in public domain. An in-depth study might also contribute towards using improving methodology of data collection during census as well as identify strengths and weaknesses of the micro-data.

10. Each set of observations arrived at the data center after research would be the end result of decision rules covering definitions, classifications, coding procedures, processing, editing, etc. The validity and consequences of all these decision rules only become evident when the ORGI's micro-databases would be tested in the course of analysis. Exposing to the light of research the conceptual and processing assumptions that are embedded in the Census micro-databases constitute an important element in improving the quality of data.

#### **III. LOCATION:**

11. As agreed to by the **Second Party**, the workstation shall be located at the following address.

International Institute for Population Sciences (IIPS) B.S. Devashi Marg, Govandi Station Road, Deonar, Mumbai, Maharashtra 400 088

#### **IV. FACILITIES AVAILABLE**

12. The workstation will be fully equipped with all the facilities for research on confidential micro-data from Census 2001, Census 2011 & onwards. The workstation will be fully air-conditioned and would have a network of computer terminals for accessing the data. An official from the university will be posted at the workstation to provide access to the data sets required in the approved research proposal.

13. The researcher will be permitted to use only the software made available at the workstation for tabulation. The researchers may also use the printer installed in the workstation to print the approved outputs. She/he will however not be allowed to take out the soft copy of the micro-data in any format.

#### V. SUPERVISION OF THE WORKSTATION

14. The Second Party agrees to nominate Department of **Computer Section in International Institute for Population Sciences (IIPS) Mumbai** as the Department responsible for setting up and maintaining the workstation on behalf of the University/Institute. The Department also agrees to foster and promote research at the workstation as agreed to in this MOU.

15. The Second Party also agrees to appoint a senior faculty member of the Department as the sole In-charge for the proper functioning of the workstation. University/Institute also agrees to appoint a separate faculty member to support the In-charge.

#### **VI. STEERING COMMITTEE**

16. For examining the research proposals received from scholars, students or any other person for undertaking research, a Steering Committee will be constituted by the International Institute for Population Sciences (IIPS), Mumbai. The Steering Committee shall comprise of four members, two members from the International Institute for Population Sciences (IIPS), Mumbai and two other members from the DCO/Office of Registrar General, India. The Steering Committee will meet regularly to examine the research proposals received at the workstation and accord permission for research, if found suitable. The facilities available at the workstation will only be open to researchers whose research proposal has been accepted and approved by the Committee. In case, the dataset is not available at the workstation, or up to the time it is not available, the Faculty-in-Charge would forward the request for generating cross tabulations to the Data Dissemination Unit, Office of the Registrar General & Census Commissioner, India, New Delhi for consideration. If approved by the Census Commissioner, India the tables would be generated at the ORG&CCI and made available to the research scholar. The Steering Committee would make its own rules for operating the workstation. The nominated members from the First party would have the right to convene the meeting of the Steering Committee, if necessity arises.

#### VII. WHO PROVIDES THE DATA FOR RESEARCH

17. After the proposal from a Research Scholar is approved by the Steering Committee, the Faculty in-charge would direct the person posted at the Workstation to allot a Computer terminal and make available the data.

#### **VIII. RESTRICTIONS TO BE FOLLOWED**

18. In order to maintain the confidentiality of the data and also to supervise and monitor use of the micro-data, it is not permissible to take out or copy the data. The researcher would be allowed to process the micro-data using the software as available in the workstation and generate the table(s) for

use in her/his research. Only computer print-out of the tables so generated will be allowed to be taken out of the workstation. For this purpose, the researcher would have to fill in the prescribed form and obtain permission of the supervisor.

# IX. SUPERVISION AND GUIDANCE

19. The Second Party shall nominate a senior faculty member of the concerned Department of the university for supervising the workstation. She/he would be assisted by a junior Faculty Member in this work. The entire operation at the workstation would be supervised by the faculty so designated.

## X. SETTING UP WORKSTATION

20. The Second Party agrees to set up the workstation as per modalities suggested by ORGI and elaborated in this MOU for research on micro-data from Census. The expenditure for setting up of workstation is to be borne by the Second Party.

# XI. RESPONSIBILITY OF THE SECOND PARTY

21. The Second Party, on its part, agrees to undertake and fulfill the following responsibilities in setting up, maintaining and fostering research at the Workstation being set up with the support from ORGI.

- (a) The Second Party agrees to bear all the expenditure in setting up of work station.
- (b) The Second Party agrees to allot suitable room/hall with space of about 1000 sq. ft. space to set up the workstation to the satisfaction of the office of RG&CCI or any officer nominated by him.
- (c) The Second Party agrees to undertake civil work (like, partitioning, painting, etc.) to create separate rooms for use as (i) Server Room, (ii) Terminal Room where the Desktop PCs will be installed to access the data, (iii) Supervisors room and (iv) Reception area.
- (d) The Second Party agrees also to undertake electrical work to provide adequate lighting, air conditioning and necessary points.
- (e) The Second Party agrees to make available Computers, Server, Desktop PCs, UPS, Printer and the software required (vide list below).
- (f) The Second Party will keep up to date the workstation.
- (g) The Second Party agrees to allow the use of space originally allotted for setting up the workstation. In case, the site has to be shifted to a new location all expenditures towards setting up the workstation will be borne by the Second Party.
- (h) The Second Party agrees to ensure proper maintenance of all equipment's from its own fund.
- (i) The Second Party agrees to ensure security and cleanliness of the workstation and its surrounding areas.
- (j) The Second Party agrees to make available the services of one person for system administration, make available the data required by the researchers

and overall supervision, The Second Party also agrees to arrange for fund required towards payment of monthly salary from its internal resources which will not be reimbursable by ORG & CCI.

- (k) The Second Party agrees to monitor and supervise the research work done at the workstation and also agrees to assume full responsibility of research undertaken therein.
- The Second Party will ensure that the data hosted on the server is not copied or taken out by anyone. For this purpose, the Second Party would disable all USB Ports to disallow copying.
- (m) Only the approved output tables prepared by the researchers shall be allowed to be taken out. The Second Party agrees to be responsible for day to day running of the workstation.
