MINUTES OF THE HUNDRED AND THIRTEENTH EXECUTIVE COUNCIL MEETING OF THE INTERNATIONAL INSTITUTE FOR POPULATION SCINCES, MUMBAI

The 113th meeting of the Executive Council (EC) of International Institute for Population Sciences (IIPS), Mumbai was held under the Chairpersonship of Secretary, MoHFW on 14th December, 2023 at 10:00 AM at Nirman Bhavan, New Delhi, Ministry of Health and Family Welfare (MoHFW). The list of participants is given at **Annexure - I**.

At the outset, DG (Stats) welcomed the Chair and EC members to the meeting. After introductory remarks, item-wise agenda was discussed in the meeting. The agenda of the meeting is given at **Annexure - II**. After due deliberations on various agenda items, the following action points emerged.

Item No. 1: Confirmation of the Minutes of the 112th Meeting of Executive Council held on 11th October 2022

The minutes of the 112th Meeting of EC held on 11th October 2022 were confirmed. The Chairperson directed that IIPS should ensure the frequency of EC meetings as per the Bye-laws i.e., minimum twice a year and asked the Member-Secretary to get the next EC meeting scheduled before June 2024.

Item No. 2: Action taken on the decisions of the 112th Meeting of Executive Council held on 11th October 2022

Apprised the EC about the action taken on the record of discussions in 112th EC meeting held on 11th October 2022. This was noted by the EC.

Item No 3: Approval of Audit Report and Audited Annual Accounts of IIPS Main A/c for the financial year 2022-23

The EC observed that for audit purpose, the current practice of the accrual basis of accounting for IIPS and cash basis of accounting for externally funded projects may continue. The AS&FA suggested that for consolidation purpose, the reporting of both the accounts may however be consolidated on the cash basis of accounting. The audited annual accounts for the FY 2022-23 were approved.

Items No 4: Approval of Audit Report and Audited Annual Accounts of the sponsored projects funded by the outside agencies for the financial year 2022-23

The Chairperson directed that the foreign funded projects should be aligned with the national interest. For this purpose, an internal Committee may be constituted at IIPS for examining any new foreign funded projects.

Item No 5: Recommendation for the adoption of the Annual Report for the year 2022-23

The Executive Council recommended that the annual report for the FY 2022-23 which contains the audited annual accounts along with the audit report for the FY 2022-23 may be placed before the General Council for approval.

Item No 6: Approval of Revised Estimates for the year 2023-24

However, as per the recommendation of 110th and 111th Executive Council meeting, IIPS was directed to present the progress on the implementation of the report of the Committee set up to suggest "Short, Medium and Long term implications and the Ways to Address them in line with the New Education Policy-2020 for IIPS, Mumbai" in the next EC meeting.

Item No 12: Progress of the NIDP project at IIPS

The Executive Council noted the current progress on the construction of NIDP. The Chairperson viewed the delay work seriously and directed IIPS to expedite the work.

Item 13: Proposal of the approval of Executive Council

The Executive Council approved the proposal of new gates, security cabin and compound wall for IIPS campus of Rs 3,34,76,000/- and provision of assembling and installing of Office furniture for the Administrative cum Academic building for Rs 10,51,32,000/ as per the recommendations of the Standing Finance Committee.

Item No 14: Approval for IIPS logo to be exhibited on the New Administrative-Cum-Academic building

The Chairperson directed to re-design the logo and submit multiple designs duly incorporating the true essence of the Institute for further consideration of EC.

Item No 15: Resignation of Prof. K. S. James

The Executive Council noted the resignation of Prof. K.S. James. The Chairperson directed the Ministry to initiate the process for appointment of Director and Sr. Professor of IIPS as per the existing Bye-Laws with immediate affect.

Additional agenda: Revision of MoA and Bye-Laws of IIPS

The draft MoA and Bye- Laws as per the UGC Regulation 2023 were placed before the EC. The Chairperson directed that the proposal needs detailed examination and IIPS was therefore asked to submit the detailed proposal to the Ministry first.
