MINUTES OF THE MEETING OF THE BOARD OF STUDIES OF THE INTERNATIONAL INSTITUTE FOR POPULATION SCIENCES HELD ON APRIL 08, 2025.

The meeting of the Board of Studies of IIPS was held on April 08, 2025 at 10.30 AM in Seminar Hall, IIPS. The meeting was chaired by Prof .Dewaram A. Nagdeve, Director and Sr.Professor (Additional Charge), IIPS. At the outset, the chairperson extended warm welcome to all members and external experts to the meeting of Board of Studies (BoS). Prof .Dewaram A. Nagdeve ,Director and Sr. Professor (Additional Charge) & Chairperson of Board of Studies requested Prof. K. C. Das, Member-Secretary to proceed with the agenda.

Agenda Item No.1:	To confirm minutes of the meeting of Board of Studies held on December 16, 2024.
	The members confirmed and approved the minutes of the meeting of BoS held on December 16, 2025.
Agenda Item No.2:	Action taken on the minutes of Board of Studies meeting held on December 16, 2024
	Action taken were noted.
Agenda Item No.3	To discuss & recommend the revised syllabus of all PG programme including MA (distance education).
	The BoS was briefed by the Prof. Aparajita Chattopadhyay, Chairperson regarding the background of the revision of syllabus for master degree courses in line with NEP-2020.
	Course coordinators have made brief presentation on the revised two year PG course syllabus namely MA/M.Sc, MBD, MSD & MA (distance education). Also presented the semester wise credit distribution along with research components in fourth semester. IKS, value added course and non-credit internship are included in revised course syllabus as per NEP guideline. The revised syllabus will be implemented from the academic year 2025-26. Chairperson has suggested to maintain the uniformity among the courses and revised the credit distribution as suggested by the members and also advised to submit IKS syllabus at earliest.
	In addition to above, Prof.L.K.Dwivedi, MSD coordinator has proposed for the additional requirement of four faculty members for the teaching of M.Sc in Survey Research and Data Analytics programme.
	The BoS recommended the suggestions to be placed before the Academic council.
Agenda Item No.4	To discuss and consider the various academic activities of Master of Science (M.Sc.) in Survey Research & Data Analytics .
	The BoS recommended the following suggestions to be placed before the Academic council.
	Evaluation of Dissertation: The Director & Senior Professor appoints an evaluation committee for dissertation consisting of three members from among the faculty of IIPS. First, the committee members independently assess the 'oral presentation and defence' of the student and submit their grade to the Controller of Examinations. Second, the committee members independently evaluate the content of the 'final dissertation' submitted by the student and submit their grades to the Controller of Examinations. To

arrive the final dissertation grade, the average of overall grades of Guide, Presentation & Defence, and Content is considered.

Dissertation: Weightage for evaluation of dissertation: Guide 0.25; Presentation & Defence 0.25; and Content 0.50

Viva voce: Director & Senior Professor constitutes a committee comprising of one external examiner and three/four internal examiners for the vivavoce. The three/four internal examiners shall comprise of one senior professor (Chairperson), one/two faculty members and one programme coordinator. The committee members independently evaluate the performance of the students in the viva-voce and assign their grades. To arrive the final viva-voce grade, the average of the evaluation of the members is considered.

Agenda Item No.5 To discuss and Introduce IIPS Gold & Silver Medal and IIPS Award for Best Dissertation in Master of Science (M.Sc.) in Survey Research & Data Analytics.

In case of Master of Science (M.Sc.) in Survey Research & Data Analytics, the BoS recommended the following suggestions to be placed before the Academic council.

First rank is decided on the basis of student securing highest Combined Grade Point Average (CGPA) and will be awarded IIPS Gold Medal likewise second rank is decided on the basis of student securing the second highest CGPA and will be awarded IIPS Silver Medal. Other terms and conditions as per the examination manual.

In case of best dissertation award, the following points are proposed: -

- Introduce new award for second year students namely i) IIPS Award for Best Dissertation in Master of Science in Survey Research & Data Analytics from the Academic Year 2025-26 onwards.
- Three external member committee will evaluate the Best Dissertation Awards from the top five ranks (based on the combined score of content, presentation & defence) dissertations.
- The Award will be announced & distributed in the Convocation of the Institute.
- The Award will consists of Gold Medal & Certificate.

The BoS recommended to put up the same in the forthcoming Academic Council for approval.

Agenda Item No. 6 To report about the Value Added Courses.

The BoS noted the progress of value added courses and recommended the same to be placed before the Academic council.

Agenda Item No. 7 To discuss about the examination manual.

- 2. IQAC coordinator suggested to collect & record awards of Ph.D students through digital mode at time of submission of half yearly progress report. Academic support cell will look into the execution of the work.
- 3. The revised eligibility criteria for the admission of International students were discussed. The BoS recommended the same to be placed before the academic council.
- 4. Based on the student's request regarding the resume of Ph.D. in Biostatistics and Demography, the matter was discussed and it was decided that Prof. Laxmi Kant Dwivedi and Prof. Nandita Saikia will be prepared a proposal. The proposal will be presented in the faculty meeting and accordingly the same agenda will be discussed in BoS & AC.
- 5. The request from Ms. Ragini Mishra for re-registration in the Ph.D. program was discussed. It was reported to the BoS that her earlier request was not approved by the Academic Council due to the unsatisfactory Ph.D. work. The BoS decided to comply with Academic Council decision.
- 6. Regarding the MPS course, the Chairperson suggested to sending a reminder letter to the UGC under the intimation of MoHFW.
- 7. It was decided by BoS that fellowship of Semester IV students [MA-M.Sc. and MBD] will be released up to 30-04-2025 and the students will be allowed to stay in hostel up to the first week of May 2025. Accordingly, the academic section will inform to all the students regarding this decision.
